Spring Newsletter from the Master

Our Company has had a very busy start to the year, with numerous events and exciting initiatives, as well as welcoming eminent new members. The re-formatted Committees met in January and March, and Court convened at the end of February to progress our aims and objectives. This newsletter highlights our recent and forthcoming activities.

Strategic Plan: An update of our current strategic plan is under way to review the Company's progress over the past two years and to set the scene for the next five. We will be seeking your views on how best to continue the renaissance of the WCCA to further improve its relevance, effectiveness and outreach to our Livery, the City and our profession.

Membership Survey: The Membership Committee, led by Junior Warden Valerie Owen Le Vaillant OBE, is undertaking a survey of all our Freemen and Liverymen to better understand your views, needs and ambitions for our Company, to help shape our future strategic plan and activities. Please look out for this survey and respond!

Royal Charter: Past Master and Clerk Emeritus David Cole-Adams is preparing an application for a Royal Charter to enhance our status as a Worshipful Livery Company. Alongside this, our ordnances, bylaws and rules are being reviewed and updated, including the proposed introduction of an annual 'Common Hall' meeting for all of our Livery.

Charitable Trust Fund: The fund now stands at £610,000 and our charitable disbursements have increase by 20% this year to £18,000. We are heading towards our target of achieving £1 million in the fund by 2020, with a campaign being formulated to increase donations from our Livery and other supporters. A new Trustee has been appointed (David Cole-Adams) and an updated Trust Deed is being developed by the Trustees in consultation with the Court, to enable the future success and growth of the charitable objectives of the WCCA.

New Year Court: The Court met on 28th February at Drapers' Hall and considered our current initiatives, including developing our administrative infrastructure and possibly making our home in Temple Bar. The Court admitted 6 new Freemen and installed 14 new Liverymen into the Company. We offer a warm welcome to them all.

Company Infrastructure: The Finance and Strategy Committee, with our other Committees and Clerk Jonathan Soar, are now considering improvements in our administrative infrastructure and communications including our website, member database and financial systems, to provide a better service to our increased membership and stakeholders. Recent Events...

City Architecture Award 2016: The Right Honourable The Lord Mayor, Alderman Dr Andrew Parmley, ably assisted by the Master and Past Master Chief Commoner, Michael Welbank MBE, on 6th February, unveiled the plaque commemorating the WCCA City Building of the Year Award 2016 at One New Ludgate, designed by Fletcher Priest.

Banquet 2017: Over 230 Livery members and guests enjoyed our annual banquet in the splendour of Drapers' Hall on the evening of 28th February with musical entertainment provided by a Baroque String Quartet. The guest speaker Peter St John (Caruso St John Architects) talked about his Stirling Prize-winning Newport Street Gallery for the artist Damien Hirst.

Consort's Event "Medicinal Magic of Kew": The Master's wife, Professor Nicola Brindley, with the Wardens' Consorts, hosted a luncheon, lecture and tour of the herbarium and research laboratories at Kew Gardens on 3rd March. This was enjoyed by the Consorts of 38 other Livery Companies and highlighted the research work being done in the UK for Chinese herbal medicine.

Master's Reception: A convivial social event was held at the new Bartlett School of Architecture Building on 28th March, with presentations by the UCL Dean and Head of School. The RIBA student prize and Banister Fletcher medal were awarded to Bartlett students by the RIBA Director of Education and the Master. Tours of the new Bartlett building by the architects Hawkins Brown were led by Liveryman Roger Hawkins. The Bartlett UCL has a particular resonance for the Master who studied, examined, lectured and currently is a Post-Graduate Studies director there. A 'Part 3' client presentation course was recently run based on designing a new Livery all for the WCCA.

WCCA Monthly Gatherings: Our programme of regular informal gatherings and architectural discussions (held on the second Monday in the month) have taken place in the offices of our Livery members and got off to a great start with very enjoyable evenings at Hawkins Brown, Stiff + Trevillion and Weston Williamson. The next gathering will be at Chris Dyson's Offices 6:30-8:30pm on Monday 8th May – details to be issued shortly by the Clerk. Future practice visits on 12th June will be held at PRP Architects and on 10th July at Pitman Tozer; the Events Committee are in advanced talks for the venue on 11th September.

WCCA 2017 City Architecture Awards: Judging of the short-listed buildings for this year's WCCA awards will take place on 19th April, with a panel chaired by Paul Finch and including the Master Richard Brindley, Immediate Past Master Peter Murray and the Lady Mayoress Wendy Parmley. The winners are due to be announced and awarded at our Election Court dinner on 5th July 2017.
