

Firstly, I would like to pay tribute to and thank Immediate Past Master, Philip Cooper for steering the Company through a continuing time of uncertainty following the lockdowns and restrictions that the Covid-19 pandemic placed on our lives. His work alongside fellow trustees to secure Wren's Temple Bar allows us to use it as our new home - the City's smallest livery hall.


TEMPLE BAR



INSTALLATION COURT LUNCH

Installation Court Lunch, sponsored by Hannaford contractors - The order for the day was our Installation Court held at Temple Bar, followed by the annual Installation Service at St Giles Cripplegate and lunch at Barber Surgeons' Hall.

The top table sat under the wonderful painting of what is traditionally known as "King Henry VIII and the Barber Surgeons", The Holbein is an oil on oak panels, in a late 17th Century gadrooned giltwood frame, which shows the King celebrating the Act of Union between the Company of Barbers and the Guild or Fellowship of Surgeons in 1540, this was indeed a humbling experience.

Some weeks prior to the installation court, the Queen had died at 15:10 BST on 8 September 2022, the UK's longest-serving monarch died at Balmoral aged 96, ending her 70-year reign. So at the installation our toast was to the new King Charles 3rd. The new King had been greeted in a special ceremony 'The Proclamation' outside

the Royal Exchange; "Three cheers for His Majesty, The King," Vincent Keaveny, Lord Mayor of London, proclaimed on the steps of the Royal Exchange for the ascension of King Charles III on 10 September. Keaveny is the 693rd person to have held the Lord Mayor title. With its beginnings tracing back to the 12th century, the role has changed alongside London. The Lord Mayor has served as an ambassador for the

UK financial sector over the years, but this September the role's ancient responsibilities were once again put in the spotlight. On that Saturday, in front of huge crowds and televised to the nation — the first time a proclamation had been filmed — Keaveny stood at the heart of the City to wish the new King well.













ST PAUL'S CATHEDRAL, GARDEN OF REMEMBERANCE SERVICE 2022

In early November 2022, I attended a service at St Pauls Cathedral and a ceremony with the Lord Mayor in the Garden of remembrance. A two minute silence was observed.

"As a nation, on Remembrance Sunday we remember those who have died in war. We pray for all who suffer as a result of war today and we ask for God's help and blessing that we may continue to work together for justice and peace. You are welcome to join us at one of our Cathedral services that day.

At the going down of the sun and in the morning we will remember them."



The King insisted that each newly-elected Mayor should come to Westminster and swear loyalty to the Crown, and the newly elected Mayor of London has been making that journey for over 800 years. Around him (and her) grew up the noisy, colourful, joyous procession that over the centuries it has become known as the Lord Mayor's Show.


WARDENS ST. PAUL'S CATHEDRAL TRI FORUM TOUR

A new tradition, hopefully, was to pull the Wardens all together with our partners and enjoy a tri forum tour of St Paul's Cathedral, the areas most people do not normally see without a guide. Our guide for the morning was Emma

Krais who has been a tour guide for many years. Emma gave a 2 hour long interesting tour Wren hidden gems!

All this dovetailed nicely with the wren 300 being

celebrated this year in his memory, a plethora of events across the square mile will be taking place both from within our company and other liveries across the city including some 52 Wren Churches, Sir Christopher Wren was 33 years old and near the beginning of his career as an architect when the Great Fire of London in 1666 destroyed many of the city's public buildings, including 88 of its parish churches. Wren's office was commissioned to build 51 replacement churches and St Paul's Cathedral. Many of these buildings survive to this day; others have been substantially altered or rebuilt. Some buildings were completely or partially destroyed during the German Blitz of 1940-41; yet others demolished for different reasons.

BUILDING OF THE YEAR AWARDS 2022

The City of London Building of the Year Award is the Worshipful Company of Chartered Architects prize for the best new building completed in City of London, and a celebration of the contribution architecture makes to the civic life of the Square Mile.

The long-list for the awards selected by Annie Hampson OBE, Chief Planning Officer and Development Director of the Department of the Built Environment, were then shortlisted by the Jury for visits. The shortlisted projects were visited by a jury that included The Master, The Sponsors and two WCCA

members. The 2022 judging panel comprised: Philip Cooper (Master WCCA), Chris Dyson (Upper Warden WCCA), Chris Williamson (Renter Warden WCCA), Richard Brindley (Past Master WCCA), Samantha Dean (Freeman WCCA) and Paul Finch (Freeman WCCA, Judging Chair).



The winning project, Emperor House (Urbanest City), was designed by Hopkins Architects for Urbanest and APT acted as interior and delivery architect for the project. It was selected from a shortlist of six projects by the judges.

Located at 35 Vine Street in the Tower ward of the City of London, Emperor House is a mixed-use development containing 656 student accommodation flats alongside offices, student study spaces, café facilities and a separate office floor for 'incubator' use. The building straddles a section of the City of London's historic Roman wall, which the project has made visible from the street. Space for a new public viewing facility for the wall, operated by the Museum of London, has been created in the basement. "The judges found merit in every building visited this year and commended the high standards of design achieved.

"Emperor House is a good example of architecture which gives far more than it takes, and whose substantial mass and form manages to appear modest in its context. The judges were particularly impressed by the variety the design manages to provide on four sides of a complex plot."

Judges' Comments:

This project has an unusual history, having started life as an office development but changing to become a true hybrid.

The key element is student accommodation for client Urbanest, with offices still provided and separately owned at the northern end of the site, while a new public facility for the Museum of London separates the two elements, revealing substantial remains of the Roman Wall.

The challenge of creating a building which responded to such a variety of requirements, which also included student study space, café facilities and a separate office floor for 'incubator' use, resulted in the architects exploring a series of approaches, settling on what has now been built, with the interior and delivery team (APT) staying true to the original design intentions. The judges were particularly impressed by the variety the design manages to provide on four sides of a complex plot. It engages with Vine Street, with a response to a historic square; India Street, where the office entrance is commanding without being overbearing; Jewry Street, where the façade introduces a setback allowing for a planting intervention and manages to incorporate a curved element

breaking the horizontal plane; and Crosswall, where a modest addition with party walls either side makes its mark with a simple colonnade. The curved roof incorporates study spaces with impressive views across the City. This is a good example of architecture which gives far more than it takes, and whose substantial mass and form manages to appear modest in its context.



TEAM BUILD 2022

Past Master Richard Brindley and several of our members have made this restart a complete success, and I highly recommend member practices encourage the younger members of their offices to engage with this fun weekend event. This report is Richards' appraisal for the WCCA.

There is a continuing role that the WCCA, with other relevant Livery Companies, could have in developing and supporting the Teambuild initiative. The UK Construction Industry and the professions that Teambuild relates to have changed significantly since it started 30 years ago. But the need for collaboration/ leadership/networking/ communication skills in the industry's young professionals is still very prevalent and relevant, and there are not many other training programmes focusing on this issue.

As we go to press Richard Brindley has stepped down from this role and Christopher Williamson will take up the position.




ECO HOME, PATERNOSTER PAVILION

HONORARY LIVERYMAN Eugene Kohn, KPF

18th January 2023



Having arrived at our decision by a unanimous vote of our Court, the WCCA are most honoured that Gene has accepted our invitation to be an Honorary Liveryman of our Company. Eugene Kohn of KPF in USA and UK has joined the WCCA's illustrious list. We took this opportunity to welcome Gene, albeit virtually, into our new Livery Hall, Temple Bar.


As one of the founders and the global leader of Kohn Pedersen Fox, Gene Kohn built one of the most successful architectural practices of all time. Founded in 1976, the firm has worked on major developments in North America, Asia, Middle

East and Europe. Gene has travelled relentlessly, circumnavigating the globe to maintain a personal relationship with key projects and clients. His practice has had a major impact on the growth of the City of London and its success as an international business hub. At the time of Big Bang, along with US consultants like SOM, Gensler and HOK, it brought to London an expertise in delivering the highly serviced, large floor plate offices required by the global finance industry.

A key part of the practice's approach has been its proud support of the commercial office building as the fundamental building block of the modern city. The Eastern City Cluster owes much to KPF's enthusiasm for the dense, efficient city, as well as the picturesque arrangement of towers rising to a pinnacle. All while conforming to the wider principles of the London View Management Framework. When KPF faced a little local difficulty with some of its partners setting up a rival practice, Gene moved overnight from New York to London to restructure the business, making very clear his personal commitment to London as an important design hub and home of the practice.



2023 MASTERS TRIPS & EVENTS

06th FEBRUARY

CONSTRUCTION LIVERY GROUP

Is being reignited and 10 members and masters will meet for the first time since the pandemic at Temple Bar for lunch on the 6th February 2023 to discuss our plans for a more united and inspiring future together.

The Company is a full member along with 24 other Livery Companies allied to the Construction Industry in some way or another. CLG is formed with Livery Craft Skills Council (LCSC) and works closely with The Construction Youth Trust and The City & Guilds.

21st FEBRUARY

CPD Event - Designing, delivering and managing safe buildings through Better Information Management (BIM)

In April 2022, the Building Safety Act transformed major parts of the UK construction industry into a Regulated Industry. This means that designers and contractors must create and maintain a Digital Record of what products have been selected, how they should perform, how they were installed and commissioned, if they were "value engineered", what was the replacement. Once completed, the information asset teams need to onwardly manage the building in a safe and effective manner, must be delivered.

Although this is all common sense and when the Government made BIM mandatory, the principle goal was to deliver reliable and easily managed asset information – not cool 3D modelling. This was defined in two, now almost forgotten, requirements - Government Soft Landings (GSL) and BIM Level 2. They formed the start of the journey but methods of procurement derailed it and very few projects – even those held up as exemplars – actually delivered what was required – Better Asset Information (BAM?). Ten years on, GSL seems now to have been replaced by "the Golden Thread" which seeks to achieve the same outcome.

However, there is a difference.

Statutory compliance – and therefore the risk of financial, even criminal penalties.

This should be the game-changer. If required information is not provided in the Digital Record, it should be considered as a "Defect".

In some ways, creating the right information is as important as doing the work. If the space naming in a schedule of accommodation is (even slightly) different than the reference code on a floor plan, that can be a major defect, because links to any information that relates to those spaces such as performance requirements, installed equipment and safety risks – will be broken.

This session will explain the building blocks we have been putting in place to make it easier for designers to deliver into the Golden Thread.



WCCA BOOK FESTIVAL

Plans for the first WCCA Annual Book Festival are well underway. There will be book readings and presentations in Temple Bar and hopefully stalls in Paternoster Square. There will be an Awards ceremony covering 10 categories of on line and printed material. The event is being organised to be part of the London Festival of Architecture.

The area is an important part in the history of publishing. This 1837 engraving depicting a book fair in Paternoster Row was forwarded by Oliver Garland. 'Following the Great Fire, the stationers and book-sellers merchants moved into Paternoster Row, and by the eighteenth-century Paternoster Row was dominated by booksellers and book publishers, who simply called it 'The Row'. By the turn of the nineteenth century 'The Row', along with the book trading area of St. Paul's churchyard, was considered the centre of the British book trade for publishing and selling alike – the booksellers often had agreements with certain publishers too to sell their publications. 40 publishers were based here, producing between 500-700 new titles per year'

WREN 300 SERVICE at St Paul's Cathedral

As part of Wren 300 the Architects and Surveyors Livery Companies have organised a service at St. Pauls Cathedral on Tuesday June 27th at 11.00 am to be followed by a series of lunches at five livery halls to accommodate up to 1,000 people, provisionally the following are involved.

A number of other livery companies will be involved as well as the RIBA, RICS, Gresham College, Cambridge University, Oxford University, The Georgian Society and many other organisations with whom Wren was associated. Helen Vigors of the Diocese of London is liaising closely and has a substantial contact list for us engage with.

Our two livery companies have agreed to underwrite £15,000 each of the anticipated cost of up to £45,000 of the service at St. Pauls, although we seek to reduce this burden of cost substantially. We have invited the Construction Liveries Group to become involved and have proposed three sponsorship categories.

About Sir Christopher Wren

Sir Christopher Wren (1632-1723) is Britain's greatest architect. St Paul's Cathedral in London is his masterpiece of design taking it took 35 years to build. He was Surveyor-General to six English monarchs. His most famous buildings are at the centre of national life and ceremonials. They include Royal palaces, the Royal Hospital, Chelsea and 52 churches built after the Great Fire of London in 1666.

Christopher Wren was a child prodigy. He entered Oxford University at 17 years of age in 1649/50 during the English civil wars. He was already famous as an astronomer, mathematician and inventor before he took up architecture in his thirties. He taught himself architecture with the assistance of books.

Wren was a polymath and a practical intellectual. He is sometimes referred to as 'the British Leonardo'. He excelled in many disciplines, including physiology, geometry, meteorology and drawing. As a child he made sundials; as a student he dissected human bodies; as an astronomer, he identified the rings of Saturn.

Wren's legacy for us today is not only measured in the national heritage of wonderful buildings he designed but also as an extraordinary example of what a combined education in science and the humanities can offer.

The Wren 300 UK national festival in 2023 marks the 300th anniversary of his death at the age of 91 in 1723.

Wren 300 is a showcase for independent events and initiatives and a source of general knowledge about Sir Christopher Wren's life and career

Wren 300 aims to educate and inform a global audience about Christopher Wren's astonishing achievements across a wide range of practical subjects and intellectual disciplines.
