Highlights the traumatic histories of those fleeing persecution due to sexual orientation, and the medical, social, psychological, and legal implications of this.

An article outlining the timeline of what has happened in Chechnya over the first two years.

Russia: New Anti-Gay Crackdown in Chechnya (Human Rights Watch, 2019)

The Human Rights Watch news article regarding the situation in Chechnya including interviews with four men that escaped Checnya, detailing their personal experiences of detention, violence and persecution.

Chechnya LGBT: Dozens 'detained in new gay purge (BBC, 2019)

Provides an overview of the political situation in Chechnya, the reports by the Russian LGBT Network of the targeting of LGBT people in Chechnya and the Chechen government's response to the situation.

LGBT persecution in Chechnya: Bisexual woman beaten, drugged and exorcised (Sky News, 2020)

Article focuses on the experience of one bisexual woman who escaped Chechnya after years of physical abuse, conversion therapy by psychiatrists and religious healers, highlighting the particular difficulties women face in escaping the region.

Overview of the situation in Chechnya by detailing the experience of one man who survived torture in Chechnya. Highlights the reality of being LGBT in Russia, the particular difficulties women face in escaping the situation and the lasting effects after escaping the situation.

Books

Beyond the Pink Curtain: Everyday Life of LGBT People in Eastern Europe (Roman Kuhar & Judit Takács, 2007)

Drawing on social scientific and empirical research, book contributors present the lived experiences of queers, still haunted by the metaphor of being locked behind the Iron Curtain.

Soviet and Post-Soviet Sexualities (Richard Mole, 2019)

The book tries to make sense of the paradox that while post-revolutionary Russia was one of the first to decriminalise same-sex acts between men, attitudes towards non-normative sexualities became increasingly hostile in the Soviet Union as well as in contemporary Russia and other post-Soviet countries.

Russian Homophobia from Stalin to Sochi (Dan Healey, 2018)

Drawing on his analysis of archival documentation, Dan Healey argues that the rise of homophobia in contemporary Russia should be attributed to specific political and ideological conditions rather than an imaginary 'Soviet mindset'.

Other

Russian LGBT Network

A non-governmental human rights organization featured in the film that promotes equal rights and respect for human dignity, regardless of sexual orientation and gender identity - Organisation working to expose the situation in Chechnya, advocate for change and support LGBT people to escape the situation.

Moscow Community Center for LGBT+ initiatives

Organisation featured in the film working on multiple LGBT+ projects to give safe spaces for LGBT+ individuals, provide legal support and promote LGBT+ rights in Russia.
