Since our foundation, we have gained significant expertise in safe childbirth, the de-institutionalisation of care, palliative care for children, support for families of children with disabilities, and inclusive education.

We have an excellent track record of delivering innovative training programmes and participatory forum meetings, organising regional professional conferences and international study visits.

Foreword

HealthProm started working in Eastern Europe and Central Asia 35 years ago. The world has changed a lot in that time. Yet the challenges that are faced by vulnerable children and their parents remain significant. We are proud of what we have achieved over the years to help, but recognise there is still much we can do.

There is better evidence of what interventions work best to improve children's lives; evaluation of the impact of our activities has contributed to that collective knowledge. There is more political awareness of the issues and a heightened recognition of the need to address the rights of children and those with disabilities.

As we know from around the world, changing people's attitudes, giving greater voice to the vulnerable and ensuring alternative child care options are properly tested and safe all require time, persistence and sustained support. We hope we can continue to provide it.

This report gives detail of our work over the last year. We are pleased to be supporting local organisations and initiatives that are changing the lives of vulnerable children and their families.

OUR HISTORY A BRIEF TIMELINE

- 1984** • UK-USSR Medical Exchange Programme founded, focusing on general public health, child psychiatry, paediatrics and obstetrics.
- 1991** • Name changed to HealthProm.
- 1992** • HealthProm advises the UK Government on the development of a health cooperation programme between the UK and Russia, aimed at supporting professional exchange and evidence-based training.
- 1994-2006** • HealthProm develops new expertise in social care for vulnerable children and children with disabilities. It expands into several new countries in Eastern Europe and Central Asia.
- 2006 onwards** • HealthProm develops new programmes to support children with disabilities and develop community-based alternatives to institutional care of young children.
 - Work in maternal and child health continues with a programme to address maternal and under-5 mortality in Afghanistan.
 - HealthProm develops its work promoting inclusive education for children with disabilities.
 - New areas are developed, including mobilising parent advocacy for the rights of children with disabilities, civil society engagement and supporting children with severe disabilities requiring palliative care.

Afghanistan

We have been working in rural areas of Balkh Province since 2008 to improve maternal, newborn and child health through a range of initiatives at the community level. Our approach also addresses wider determinants of health through improving nutrition and livelihoods as well as access to clean water.

The project reduced maternal mortality to **10%** and child mortality to **13%** of the national Demographic and Health Survey 2015 estimates

Irrigation pipes serving **20 villages** were laid and **6,600 fruit trees** were planted

An independent review for DFID said that our project was “an **exemplar** for many other organisations and received global attention”

Belarus

Our work in Belarus aims to protect and promote the rights of children with severe disabilities and life-limiting conditions in four regions. A key component of this work has been the development of an innovative community-based advocacy service for families.

160 multidisciplinary participants attended our international conference in Minsk in November 2018

734 children with severe disabilities and life-limiting conditions across the country received advocacy support

Russia

Our project in Russia promotes and strengthens capacity in inclusive education for children with disabilities across four regions of Siberia. We work across sectors, involving local community groups, parents of disabled children, schools and local Departments of Education in each region.



138 teachers and social workers received training in inclusive education

72 participants from across Siberia attended our inclusive education conference in April 2019

We supported the **capacity development** of our local partner not only in inclusive education but also in organisational development and financial sustainability

Tajikistan

In Tajikistan, we work with three local partners, UNICEF, and professional colleagues from three UK-based organisations to support the Government of Tajikistan to develop safe, community-based social services to reduce the social exclusion and institutionalisation of vulnerable young children.

The number of babies living in the four Baby Homes **fell by 17%** because of better family support

560 families were supported, including **60 rurally isolated families**

Professionals improved their skills in safer care and development through **13 training courses**



Ukraine

Our work centres upon building a strong foundation for parents of children with disabilities to advocate for Early Childhood Intervention (ECI) services in Ukraine. Working across ten regions, our project focuses on mobilising and building the capacity of parent-led civil society organisations to engage with policy makers and advocate for ECI at local and regional levels.

We launched a new initiative supporting Russian-speaking women from Eastern Europe and Central Asia living in London.


MOLDOVA
